Although the school was to outgrow the site and move to Surrey in 1872, the almhouse has remained within the beautiful central London estate, but for a short period when almhouse and school were temporarily reunited on the school campus in Godalming as a result of the Blitz in the Second World War. It is for this reason that the Charterhouse is home to an historic and fascinating array of buildings, some of which date back to the fifteenth century. In its environs visitors and Brothers (of the almshouse) alike inhabit surroundings that evoke the slow passage of time and where the history of London and England are easily recalled.

Bequests to Sutton's Hospital in Charterhouse (registered charity number 207773) play a vital role in preserving and enhancing the buildings so that future generations can continue to visit this London treasure and engage with the lives of generations of our forebears. Those who support the Charterhouse in this way assist us in delivering our principal function which is to provide accommodation and support to a community of elderly men (the Brothers of Charterhouse) who have demonstrated that they are in need of financial and social support. Brothers come from a wide variety of professions. These include teachers, clergymen, writers and editors, musicians and artists. Many have served in the armed forces. At entry they are usually between 60 and 80 years of age and have to be in good health. They must also have a desire to live together in a community following a very simple set of rules. However, their accommodation is entirely private. The Brothers are supported by a ten bed infirmary registered with the Care Quality Commission.

HOW LEGACIES HELF

The oldest part of the Charterhouse dates back to 1349 and the site includes mediaeval, Tudor and Jacobean buildings. Maintaining this important and historic estate is very expensive, one that becomes more so with each passing year. In order that future generations can experience this living monument the Governors of the Charterhouse have created a new endowment fund. This has been ring-fenced so that the capital is protected and only the income generated annually from this fund can be spent. In this way this fund will provide revenue for the estate in perpetuity and may also be utilised for the care of the Brothers of Charterhouse, who have served their communities well during their lifetimes but who do not have the financial resources to enjoy their old age. Any bequest will be put into this fund unless otherwise advised.

Bequests to the Charterhouse will enable us to continue to serve the young, through our education programmes, and old alike just as Thomas Sutton made provision for four hundred years ago.

If you wish to direct your legacy towards a particular area, for example to support the maintenance of the estate, you can rest assured that we will respect the terms of legacy gifts as stated in your will.

LEAVING A LEGACY

Writing a will is neither complicated nor unduly expensive and, if you have already done so, you will recognise the comfort that comes from ensuring that your estate will be used to benefit the people and causes that are closest to you.

There are two principal types of legacy gift; a residuary bequest and a pecuniary bequest. A residuary bequest is one which either the residue or a specified part of the residue of the estate in question will go to the stated recipient after taxes and other deductions have been made. A pecuniary bequest is a specified sum of money and as a result is neither inflation-proofed nor adjusted according to circumstances. If you have already made a will and have not named the Charterhouse as a beneficiary but would like to, you can use a codicil. This adds a new instruction to your existing will. Your solicitor will be able to advise you on how to do this. Alternatively, please see some suggested wording on the back page of this leaflet.

If you intend to leave a bequest to Sutton's Hospital in Charterhouse, or if you have already done so, we would like to be able to thank you and to keep you informed of news at the Charterhouse. We would therefore be grateful to you if you would complete the attached confidential form and return it to us, or alternatively you might prefer to speak to someone directly and we would be delighted to receive your telephone call.

Everyone who has informed us that they have left a bequest to the Charterhouse becomes an honorary member of The 1611 Society, named after the year of our foundation. Every year, Charterhouse will host an evening of entertainment for members of the society and their guests. This will present members with an opportunity to hear news of the Charterhouse directly from those who live and work within its historic walls. Members will also receive an annual report.
